(b) The age of the youngest child in the group shall determine the:

- 1. Staff-to-child ratio; and**
- 2. Maximum group size.**

Findings:

General: Based on observation and interview, the child care center failed to maintain compliance with regulatory staffing requirements. Observation revealed nineteen (19) children in Group 1. Interview with the staff member revealed the youngest child in the group was five (5) years old. The ratio was out of compliance for approximately one (1) hour. Group #2 contained twenty-two (22) children ranging in age from 6 years through 9 years, with one staff member for more than one (1) hour.

385 - Personnel File

922 KAR 2:090. Section 9. Records.

(1) A child-care center shall maintain:

(e) A current personnel file for each child-care center staff person to include:

- 1. Name, address, date of birth, and date of employment;**
- 2. Proof of educational qualifications;**
- 3. Record of annual performance evaluation;**
- 4. Documentation of compliance with tuberculosis screening in accordance with Section 11(1)(b) of this administrative regulation; and**
- 5. The results of background checks conducted in accordance with 922 KAR 2:280;**

Findings:

General: Based on interview and review of documentation, the child care center failed to have documentation including a staff member's name, address, date of birth, date of hire, proof of educational requirements, documentation of compliance with tuberculosis screening, and results of background checks, for a staff member with a hire date of 06/02/10. Interview with the staff in charge revealed the documentation was not available at the time of the survey.

390 - Educational Requirements

922 KAR 2:090. Section 11. Staff Requirements.

(1) Child-care center staff:

(a) Hired after January 1, 2009, who have supervisory power over a minor and are not enrolled in secondary education, shall have a:

- 1. High school diploma;**
- 2. GED or qualifying documentation from a comparable educational entity; or**
- 3. Commonwealth Child Care Credential as described in 922 KAR 2:250;**

Findings:

General: Based on interview and review of documentation, the child care center's files failed to reveal a high school diploma, GED or other qualifying documentation from a comparable educational entity or a Commonwealth Child Care Credential for staff members with hire dates of 09/19/19 and 06/02/10. Interview with staff in charge revealed the documentation was not available at the time of the survey.

395 - TB Verification

922 KAR 2:090. Section 11. Staff Requirements.

- (1) Child-care center staff:**
(b) Shall provide, prior to employment and every two (2) years thereafter:
 1. A statement from a health professional that the individual is free of active tuberculosis; or
 2. A copy of negative tuberculin results.

Findings:

General: Based on observation, interview and review of documentation, staff files failed to reveal negative results from a tuberculin test or a written statement from a health care professional stating that staff members with hire dates of 08/17/17, 08/24/18, 09/19/19, and 06/02/10 were free of tuberculosis. Interview with staff in charge revealed the documentation was not available at the time of the survey.

410 - Training

Not In Compliance

922 KAR 2:090. Section 11. Staff Requirements.

- (16) In accordance with KRS 199.896(15) and (16), a staff person with supervisory authority over a child shall complete the following:**
(a) Six (6) hours of cabinet-approved orientation within the first three (3) months of employment;
(b) Nine (9) hours of cabinet-approved early care and education training within the first year of employment, including one and one-half (1 ½) hours of cabinet-approved pediatric abusive head trauma training; and
(c) Fifteen (15) hours of cabinet-approved early care and education training during each subsequent year of employment, including one and one-half (1 ½) hours of cabinet-approved pediatric abusive head trauma training completed once every five (5) years.

Findings:

General: Based on review of documentation and interview, staff members with hire dates of 08/24/18 and 06/02/10 failed to have verification of having received 15 hours of cabinet approved training in the file or on a report from ECE-TRIS. Interview with the staff in charge revealed the documentation was not available at the time of the survey.

- (4) The child-care center shall provide a daily planned program:**
(a) Posted in writing in a conspicuous location with each age group and followed;
(b) Of activities that are individualized and developmentally appropriate for each child served;
(c) That provides experience to promote the individual child's physical, emotional, social, and intellectual growth and well-being; and
(d) Unless the child-care center is a before- or after-school program that operates part day or less, that offers a variety of creative activities

including:

- 1. Art or music;**
- 2. Math or numbers;**
- 3. Dramatic play;**
- 4. Stories and books;**
- 5. Science or nature;**
- 6. Block building or stacking;**
- 7. Tactile or sensory activity;**
- 8. Multi-cultural exposure;**
- 9. Indoor or outdoor play in which a child makes use of both small and large muscles;**
- 10. A balance of active and quiet play, including group and individual activity;**
- 11. An opportunity for a child to:**
 - a. Have some free choice of activities;**
 - b. If desired, play apart from the group at times;**

Findings:

General: Based on observation, the child care center failed to provide a daily planned program. Observation revealed children without activities appearing to "hang out" with no direction of a planned activity. Children were observed walking aimlessly or sitting without an activity. Interview with the staff in charge revealed a school activity prevented the children from utilizing the gym in the scheduled time frame, and the weather prevented an outdoor time.

922 KAR 2:120. Section 3. General Requirements.

(4) A child shall:

- (a) Be helped with personal care and cleanliness based upon his or her developmental skills;**
- (b) Except as established in paragraph (c) of this subsection, wash his or her hands with liquid soap and warm running water:**
 - 1. a. Upon arrival at the center; or**
 - b. Within thirty (30) minutes of arrival for school-age children;**
 - 2. Before and after eating or handling food;**
 - 3. After toileting or diaper change;**
 - 4. After handling animals;**
 - 5. After touching an item or an area of the body soiled with body fluids or wastes; and**
 - 6. After outdoor or indoor play time; and**
- (c) Use hand sanitizer or hand-sanitizing wipes if liquid soap and warm running water are not available in accordance with paragraph (b) of this subsection. The child shall wash the child's hands as soon as practicable once liquid soap and warm running water are available.**

Findings:

General: Based on observation, the children were served snack and then allowed to enter into activities for an extended period of time prior to washing their hands after eating.
