Findings:

Room #1 Cafeteria: Based on review of documentation, the staff failed to follow the posted daily schedules. Review of the schedules revealed five (5) programming periods; i.e., 3:45-4:10 restroom and snack for entire group; 4:10-4:45 small groups to areas; 4:45-5:20 small groups to areas; 5:20-5:50 small groups to areas; 5:50-6:00 large group gathers in cafeteria. Continued observation revealed the three small groups failed to rotate through the schedule; i.e., group #1 (1st and 2nd grade children) went to the restroom at 4:05 p.m., then some of the children chose to have snack while others went right to centers and began to play. This group spent the rest of the survey period in the cafeteria playing in centers and with table toys. They failed to rotate as indicated on the daily schedule. During interview the site director stated he was aware that the groups failed to rotate on schedule and stated further that it was a work in progress.
