General: Based on review of documentation and interview, a caregiver hired 08/17/16, completed 13.5 hours of annual training.

 - 4. Nonabsorbent;**
 - 5. Easily cleaned; and**
 - 6. Free of any items not used for diaper changing.**

Findings:

General: Based on observation, there was no padded surface on two (2) changing tables in the restroom used by the children. Surveyor observed a child placed directly on a hard surface for a diaper change.

General: Based on observation, there were several exposed areas of black fabric weed-block throughout the outdoor playground.

General: Based on observation and interview, pea gravel used as the protective surface material for the outdoor play area. Interview determined the two-year-old children played on the playground where the pea gravel was located.
