 4. A copy of negative tuberculin results or a health professional's statement documenting that the adult is free of tuberculosis. Every two (2) years, the adult shall provide negative tuberculin results or health professional's statement documenting that the adult is free of tuberculosis.
- (b) An address check of the Sex Offender Registry conducted on behalf of the applicant for a Type II child-care center and supporting documentation shall indicate that no individual residing in the household is a registered sex offender.

 4. An address check of the Sex Offender Registry; and
- (c) Not be left alone in the presence of a child until copies of the background checks in accordance with paragraph (b) of this subsection have been received by the licensee.

Findings:

General: Based on Review of Documentation, it was found that the files for two (2) employees hired on 3-28-13 contained the results of criminal records checks that were submitted on 4-12-13. This date is not prior to or on date of hire as required by the regulation.

305 - Background checks/discharged

- (a) Director, employee, volunteer, or any person:

 3. Who is confirmed by an address check of the Sex Offender Registry and supporting document as a registered sex offender; and
 4. Who has been convicted of, or has entered an Alford plea or a plea of guilty to, a drug-related felony, and five (5) years has not elapsed since the person was fully discharged from imprisonment, probation, or parole.

310 - Personnel File

1. Name, address, date of birth, and date of employment;

 - d. Number of clock hours completed;
 5. Every two (2) years, a:
 - a. Statement from a health professional that the individual is free of active tuberculosis; or

 6. For a director, employee, volunteer, or any person with supervisory or disciplinary control over, or having unsupervised contact with, a child in care, the results of a:

 - c. Criminal records check from any previous state of residence completed once if:

Findings:

General: Based on Review of Documentation, it was found that the files for two (2) employees hired on 3-28-13 contained evidence of TB skin tests that were completed on 4-10-13. This date is not prior to date of hire as required by the regulation.

325 - CPR/First Aid Coverage

(3) For a child-care center licensed for infant, toddler, or preschool-age children, at least one (1) person on duty and present with the children shall be currently certified by a cabinet-approved training agency in the following skills:

- (a) Infant and child cardiopulmonary resuscitation; and
- (b) Infant and child first aid.

(4) For a child-care center licensed for school-age children, at least one (1) person on duty and present with the children shall be currently certified by a cabinet-approved training agency in the following skills:

- (a) Adult cardiopulmonary resuscitation; and
- (b) First aid.

330 - Adequate Substitute(s)

(14) In accordance with KRS 199.896(15) and (16), a staff person with supervisory authority over a child shall complete the following:

- (a) Six (6) hours of cabinet-approved orientation within the first three (3) months of employment;
- (b) Nine (9) hours of cabinet-approved early care and education training within the first year of employment, including one and one-half (1 ½) hours of pediatric abusive head trauma training; and
- (c) Fifteen (15) hours of cabinet-approved early care and education training during each subsequent year of employment, including one and one-half (1 ½) hours of pediatric abusive head trauma training completed once every five (5) years.

Findings:

General: Based on Review of Documentation, it was found that the files for employees hired on 1-28-12 and 2-22-12 contained evidence of only seven (7) and eight (8) hours of additional training being obtained during the first year of employment. The files for employees hired on 3-25-07, 3-10-10 and 10-10-10 contained evidence of only fourteen (14), one (1) and five (5) hours of annual training being obtained during the last completed training year.

345 - Driver Requirements
