General: Based on review of documentation, a witness reported that they saw a daycare staff person spank a child in the one and two-year-old classroom. The witness reported that the child might be the staff person's biological child. Based on interview with the staff person in charge, there is a staff person and her daughter in the one and two-year-old classroom. An interview was then conducted with the staff person in question and the staff person stated that she does spank her daughter on the bottom when she does not follow direction.

General: Based on review of documentation, it was confirmed that a staff person spanked her own biological child while she was acting as a caregiver in the one and two-year-old classroom. The staff person (parent) confirmed that she spanked the child when she would not listen.
