922 KAR 2:120. Section 2. Child Care Services.
(3)(a) Each center shall maintain a child-care program that assures each child shall be:
1. Provided with adequate supervision at all times by a qualified staff person who ensures the child is:
a. Within scope of vision and range of voice; or
b. For a school-age child, within scope of vision or range of voice;

Findings:

General: Based on interview and review of documentation, a four-year-old child was left outside on the playground for approximately two minutes on 3/18/2022. The child had hidden in a play structure during the transition from the playground to the classroom.

The staff person stated that he thought he only had one child left as he went inside classroom #9. It was not until he saw the four-year-old child pass by the window that he realized that she was still outside. He immediately opened the door and let her inside.

922 KAR 2:090. Section 10. Director Requirements and Responsibilities.
(1) A director shall:
(e) Manage the staff in their individual job descriptions;
(f) Assure the development, implementation, and monitoring of child-care center plans, policies, and procedures;
(g) Supervise staff conduct to ensure implementation of program policies and procedures;

Findings:

General: Based on review of documentation, observation, and interview, staff failed to follow the outdoor play policy.

Based on the outdoor play policy document presented for review: "Name to face is required for all transitions outside of the building and throughout the center. Teachers are to be standing and circulating the playground at all times."

The video footage presented for review shows the staff person sitting in a chair by the door before the children transition to the classroom. The staff person fails to look up and scan the playground before going inside the classroom and closing the door. Instead, he looks down and has his back turned away from the playground.

The staff person stated that he thought he only had one child left as he went inside classroom #9. It was not until he saw the four-year-old child pass by the window that he realized that she was still outside. He immediately opened the door and let her inside.
