2's Classroom: Based on Review of Documentation, during the inspection it was found that a program of activities was posted in this classroom; however, the information on it did not adequately describe the activities that children would be involved in throughout the day. The program of activities only listed one (1) activity per day such as "Farm Animals", "Baby Animals" and "Playing Together". Due to the small amount of information listed, it could not be determined if the program met the individual needs and developmental levels of each child.

Toddler's (1 year olds): Based on Review of Documentation, during the inspection it was found that a program of activities was posted in this classroom; however, the information on it did not adequately describe the activities that children would be involved in throughout the day. Most of the days on the program of activities there was only one (1) activity per day listed such as "Shadow Play", "President Barack Obama" and "Teach - I love you in sign language". Due to the small amount of information listed, it could not be determined if the program met the individual needs and developmental levels of each child.

Infants: Based on Review of Documentation, during the inspection it was found that a program of activities was posted in this classroom; however, the information on it did not adequately describe the activities that children would be involved in throughout the day. The program of activities only listed one (1) activity per day such as "We will be learning about where the birds live", "We will be learning about the different sounds animals make" and "We will be learning about where rabbits live". Due to the small amount of information listed, it could not be determined if the program met the individual needs and developmental levels of each child.

Most of the days on the schedule there was only one (1) activity per day listed such as "Shadow Play", "President Barack Obama" and "Teach - I love you in sign language".

Infants: Based on Review of Documentation, during the inspection it was found that a schedule of daily activities was posted in this classroom; however, the information on the schedule did not adequately describe the activities that children would be involved in throughout the day. The schedule only listed one (1) activity per day such as "We will be learning about where the birds live", "We will be learning about the different sounds animals make" and "We will be learning about where rabbits live".
