General: Based on Review of Documentation, the center did not maintain education document for a staff member hired 4/10/17.

(b) Pasteurized whole milk for children ages twelve (12) months to twenty-four (24) months; or

(c) Pasteurized low fat one (1) percent or fat-free skim milk for children ages twenty-four (24) months to school-age.

General: Based on Interview, six (6) preschool children were observed leaving the center at 11:00 am to attend First Baptist Church for music. Interview with the director, determined she did not have written permission, from the parents, for the children to be picked up and transported by First Baptist Church staff on 3/13/18. The director stated the children attended choir on Tuesday and returned to the center at 11:40 am.
