**Findings:**

General: Based on Observation, a caregiver left two (2) sleeping infants alone in the nursery room when she walked approximately 10 feet out of the nursery. The two (2) infants were unsupervised approximately 10 seconds. A caregiver left two (2) infants unsupervised for one and a half (1 1/2) minutes when she left the room to diaper an infant in the restroom across the hall from the nursery. Six (6) children were unsupervised when the caregiver left the room to take bottles to the nursery. A caregiver left an infant unsupervised for three (3) minutes when she took two (2) other infants to the dining room and began to prepare their lunch.

  - 4. Copy of negative tuberculin results or a health professional's statement documenting that the adult is free of tuberculosis. Every two (2) years, the adult shall provide negative tuberculin results or health professional's statement documenting that the adult is free of tuberculosis.
- (b) An address check of the Sex Offender Registry conducted on behalf of the applicant for a Type II child-care center and supporting documentation shall indicate that no individual residing in the household is a registered sex offender.

  - (d) An individual who has been convicted of, or entered an Alford plea or plea of guilty to, a drug-related felony, and five (5) years has not elapsed since the person was fully discharged from imprisonment, probation, or parole;
  - (e) A director who has been convicted of, or entered an Alford plea or a plea of guilty to, a felony offense involving fraud, embezzlement, theft, or forgery; and
  - (f) An individual who has been convicted of, or has entered an Alford plea or a plea of guilty to, an offense under a criminal statute of the United States or of another state similar to an offense specified in this subsection.
- (7) An individual who has been convicted of, or entered an Alford plea or a plea of guilty to, a nonviolent felony or misdemeanor not specified in this section shall be handled on a case-by-case basis by the licensee with consideration given to the:
  - (a) Nature of the offense;

**Findings:**

General: Based on Review of Documentation and interview, a volunteer, start date 11/30/15, had a completed child abuse/neglect check on file with results of substantiated child abuse. The child abuse/neglect check was processed on 12/15/15, and the volunteer remained present and active at the center with supervisory control of children and had been left alone to supervise children after the center received the completed child abuse/neglect check. In addition, the volunteer left two (2) sleeping infants unsupervised in the nursery on two (2) occasions. This volunteer also left an infant unsupervised in the nursery when she took two (2) other infants to the dining room so she could prepare their lunch.
