Staff stated during interview that the criminal records check was submitted on this individual's date of hire and two (2) additional times but the results have not been received. This individual has been employed more than ninety (90) days and was working alone with children during the visit.

General: Based on observation, a staff member (date of hire - 4/1/12) was working alone with three (3) children in the Nursery. During a review of this staff member's file, it was found that the file did not include a completed criminal records check. Staff stated during interview that a criminal records check was submitted on this individual's date of hire but that the results were not received as expected. Therefore, the criminal records check was submitted two (2) additional times but the results have not been received. Staff confirmed that this individual works alone with the children.
