**Findings:**

General: Based on interview, the following was found:

1. A staff person was observed by another staff person to answer her personal cell phone while changing a child's diaper on 6/7/2021, in the Infant classroom.
  2. A staff person showed another staff person an inappropriate picture of a male she had on her personal cell phone on 6/7/2021, in the Infant classroom.

**Findings:**

General: Based on interview, it was found that on 6/7/2021 an 8-month-old child was observed being fed with a propped bottle while lying on the floor in a "Boppy" pillow.
