922 KAR 2:090. Section 8. General.
(1) A licensee shall:
(a) Be responsible for the operation of the child-care center pursuant to this administrative regulation, 922 KAR 2:120, and 922 KAR 2:280; and
(b) Protect and assure the health, safety, and comfort of each child.

Findings:

General: Based on interview, three staff each stated that they witnessed another staff member getting extremely frustrated with two toddler children on 07/22/2021. Staff stated that they witnessed the staff member in question squeeze the children's cheeks, hold them up against the wall, scream into their faces and forcefully sit the children down on the floor for not listening to instruction. Staff stated that the staff member in question got very frustrated with the children and seemed to be very off that day. Staff stated that they reported their concerns to upper management and it was then reported to DCBS and the Cabinet. The staff person was removed from the classroom.

922 KAR 2:120. Section 2. Child Care Services.
(11) A child shall not be subjected to:
(a) Corporal physical discipline pursuant to KRS 199.896(18);
(b) Loud, profane, threatening, frightening, humiliating, or abusive language; or
(c) Discipline that is associated with:
1. Rest;
2. Toileting;
3. Play time; or
4. Food.
