Findings:

General: Based on observation upon the surveyor's arrival at the home, the director was outside the home at the front door allowing a dog to enter the home. When the surveyor entered the child care area in the basement at the back of the home, the director was supervising four (4) children in the child care area with no other staff member present. The director stated during interview that a household member came downstairs to the child care area to supervise the children so that she could go upstairs to attend to the dog. The director stated that the household member is not a staff member, that he has not obtained the required training, but that he does have a child abuse or neglect (CAN) check and a criminal records check (CRC) on file as required. During a review of staff and household member files, the surveyor found that the household member did have a completed CAN check and CRC on file but that there were no training records as stated by the director. Therefore, the children were not provided adequate supervision by a qualified staff member when the director left the child care area and went upstairs to attend to a dog.

- 3) A section of wood measuring approximately six inches by six inches (6"x6") was broken off one (1) side of the building at the corner approximately three feet (3') above the ground.
