Findings:

General: Based on review of documentation, review of ECE-TRIS website, and interview, the surveyor found that the provider had not obtained the required nine (9) hours of annual training for the 2014-2015 training year. Review of the ECE-Tris training website revealed that only one (1) hour of training had been completed. Upon interview the provider explained that she takes training through KET, however, she did not have training certificates on file for nine (9) hours of training.

Findings:

General: Based on observation and interview, the surveyor observed three (3) electrical outlets located in the hallway and playroom that did not have protective coverings in place. Upon interview the provider reported the children must have taken them out.

(7) An electric fan, floor furnace, or freestanding heater or fireplace shall:

General: Based on observation and interview, the surveyor found a kerosene heater stored in an unlocked closet off of the playroom that would be accessible to children. The provider explained that the heater is used for back up heat in the winter months but should be stored in the outside building.
