General: Based on Observation, it was found that the blue paint in the toy room was peeling away from the wall. The provider stated that she was aware of the peeling paint. In addition, it was found that the basement of the provider's home was flooded with several inches of black foul smelling water. During interview, the provider stated that the drains were not functioning properly. She also stated that extra cots and toys for the children were stored in this area.

General: Based on Interview, it was found that the provider did not have a copy of the certification standards available. She stated that she was unaware of the need to provide the parents with a copy. In addition, it was found that the provider only had a checklist from 2011 available for her review.

General: Based on Observation, it was found that the fire extinguisher located in the home was empty. The provider stated that she was unaware of the status of the fire extinguisher. In addition, it was found that there was not a functioning carbon monoxide detector in the home. The home is heated with gas. The provider stated that the carbon monoxide detector had fallen behind some items in her bedroom.

Findings:

General: Based on Observation, it was found that 1) an unlocked drawer in the kitchen contained several screwdrivers and mouse traps; 2) the unlocked cabinet under the kitchen sink was found to contain nail polish remover, scrub free cleaner with bleach, dishwasher detergent, Brillo pads, and Comet; 3) on the front porch, a gallon jug of Round Up, a gallon jug of Eliminator weed/grass killer and two (2) bottles of Pennzoil motor oil were present; 4) in the toy room, a box of Tandil dryer sheets, a container of Tandil laundry packs and two (2) bottles of Tandil bleach were found to be stored on the washer and dryer. Each of these containers bore the label, "Keep Out of Reach of Children." The provider acknowledged the presence of the items in the drawer, the cabinet, the front porch and in the toy room.
