(14) In accordance with KRS 199.896(15) and (16), a staff person with supervisory authority over a child shall complete the following:

- (a) Six (6) hours of cabinet-approved orientation within the first three (3) months of employment;
- (b) Nine (9) hours of cabinet-approved early care and education training within the first year of employment, including one and one-half (1 ½) hours of pediatric abusive head trauma training; and
- (c) Fifteen (15) hours of cabinet-approved early care and education training during each subsequent year of employment, including one and one-half (1 ½) hours of pediatric abusive head trauma training completed once every five (5) years.

Findings:

General: Based on Review of Documentation, staff hired on 08/28/15 had not completed the required Pediatric Abusive Head Trauma training. This was verified through ECE-TRIS.

- (f) Bar soap; and
- (g) Personal belongings and medications of staff.

General: Based on Observation, there was a bottle of glass cleaner and a container of disinfecting wipes under an unlocked sink cabinet in the hallway. The items were accessible to the children.
