<b>Findings:</b>	
General: Based on Interview, it was found that a child was involved in an incident on the playground in which he had fought with another child and a teacher had to forcibly remove the child by placing her hands on the child and moving him away from the area. While doing so, the child began to struggle and pull away from the teacher. The child ultimately ended up with bruising to his left inner bicep. The parent was not notified of the incident immediately. The girlfriend of the child's father who works at the facility was notified approximately one (1) hour and thirty (30) minutes after the incident took place when she arrived to pick up the child to go home for the day. According to interviews, the child's father was not notified of the incident by any staff member.
