General: Based on observation and interview, three (3) staff supervised thirty-nine (39) children, the age of the youngest child was one (1) year of age. The children were grouped together in the eating area from 7:55 a.m. until 8:05 a.m. Children walked around the room, mingled with other children while some children remained seated at the tables.

3 year: Based on observation, a caregiver hired 06/28/06, escorted thirteen (13) children, the youngest child a three (3) year old, from the eating area to the classroom at 8:05 a.m. The caregiver supervised the thirteen (13) children until 8:15 a.m., when additional staff arrived at the center.
