General: Based on observation, a posted written statement stated a child could not have peaches. This statement was in view to all who entered the infants' Room. Also, two (2) posted written statements stated a child was allergic to bananas, eggs, dairy, and could not have hard candy including suckers. The second statement stated a child was allergic to oranges. These statements were in view to all who entered the three (3) year olds' room.
