General: Based on observation, there was one (1) staff person caring for seven (7) children when the surveyor arrival at the child care center on 01/18/13. The staff at the center stated that the children ranged from four (4) months of age to seven (7) years of age; therefore, the center was not meeting the staff to child ratio.
