Inspection Report

Supervision

5 - Outdoor Supervision **Not In Compliance**

922 KAR 2:100 - Section 11. The General Requirements of the Family Child-Care Home Environment.
(14) Each child in an outdoor play area shall be under the direct supervision of the provider or assistant.

Findings:

General: Based on Observation, it was found that there were six (6) school age children ranging from ages five to ten (5 - 10) years of age in the back yard playing by themselves while the assistant was in the home with three (3) younger children, two (2) one-year-olds and one (1) two-year-old. One (1) of the one-year-olds came outside and was observed to be standing on a couch that was on the outside deck. This child was observed to be climbing on the banister which led to an approximately twelve (12) feet drop to a concrete ground. This HSS got the one-year-old child down from the banister and brought him into the residence. The staff in charge stated that she told her assistant that the children would need to be supervised. The staff in charge stated that she observed that the children were running around unsupervised when she came into her residence.

10 - General Supervision **Not In Compliance**

922 KAR 2:100 - Section 12. Care Requirements for a Provider.
(10) A child who does not sleep shall be permitted to play quietly and be visually supervised.

Findings:

Based on observation, it was found that on several occasions two (2) of the one-year-old children were observed to run into different areas of the home unsupervised. The provider stated that she observed that the children were running around unsupervised when she came into the residence. The provider's assistant was caring for the children in her absence.

General Administration

25 - Number of Children **In Compliance**

922 KAR 2:100 - Section 10. Standards for the Provider.
(2) A provider shall not provide care for more unrelated children than the number authorized on the certificate of operation.

Findings:

General: Based on Review of Documentation, the provider did not provide evidence of CPR and First Aid certification. The provider stated that she did not know where her documentation was located.

140 - Adult in home/Assistant

- (5) An adult living in the home of the applicant present during the hours of operation, or having unsupervised contact with a child in care, and the applicant's assistant shall submit to the cabinet:**

Findings:

General: Based on Review of Documentation, it was found that the assistant working in the home and caring for ten (10) children alone ranging from one to ten (1- 10) years of age did not have evidence of a completed child abuse and neglect check or evidence of a criminal records check on file. There was no documentation that these background checks had been requested.

145 - Adult in home/Assistant TB

In Compliance

- (5) An adult living in the home of the applicant present during the hours of operation, or having unsupervised contact with a child in care, and the applicant's assistant shall submit to the cabinet:**

General: Based on Review of Documentation, it was found that the provider's assistant who was caring for ten (10) children ranging in age from one to ten (1 - 10) years of age did not have documentation of CPR and First Aid certification. The assistant was the only adult caring for the children. The provider stated that both she and her assistant are scheduled to receive CPR and First Aid certification later in June.

165 - Assistant Training Requirements, if applicable

Findings:

General: Based on Observation, it was found that there was no programming being offered to the children in care. The assistant was not following the listed activities. Children were observed to be going in and out of the house and wandering to different areas of the home.

205 - Self-help procedures

(12) A certified family child care home shall provide a daily planned program:

(1) A provider's home and each play area used for child care shall:
(b) Have adequate:
1. Heating and cooling;
2. Light; and
3. Ventilation.

230 - Floor Level Requirements **In Compliance**

(2) Each floor level used for child care shall have at least one (1):
(a) Unblocked exit to the outside;
(b) Smoke detector;

240 - Harmful Items Inaccessible **In Compliance**

(4) The areas of the home that are accessible to children in care shall be free from items harmful to children including the following items:
(a) Cleaning supplies, poisons, paints, and insecticides;
(b) Knives, scissors, and sharp objects;
(c) Power tools, lawn mowers, hand tools, nails, and other equipment;
(d) Matches, cigarettes, lighters, combustibles, and flammable liquids;
(e) Alcoholic beverages;
(f) Plastic bags; and
(g) Litter and rubbish.

245 - Guns/Ammunition **In Compliance**

922 KAR 2:100 - Section 11. The General Requirements of the Family Child-Care Home Environment.
(5) In accordance with KRS 527.070(1), firearms and ammunition shall be stored away from the presence of children, in separate locked containers, which, in order to be opened, require a:
(a) Key; or
(b) Combination.

250 - Covered Outlets **In Compliance**

922 KAR 2:100 - Section 11. The General Requirements of the Family Child-Care Home Environment.
(6) Electrical outlets not in use shall be covered.

255 - Fan/Furnace/Heater/Fireplace **In Compliance**

922 KAR 2:100 - Section 11. The General Requirements of the Family Child-Care Home Environment.
(7) An electric fan, floor furnace, or freestanding heater or fireplace shall:
(a) Be out of the reach of a child; or
(b) Have a safety guard to protect a child from injury.

260 - Land line Telephone **Not In Compliance**

922 KAR 2:100 - Section 11. The General Requirements of the Family Child-Care Home Environment.
(8) A certified family child-care home shall have:
(a) At least one (1) working land-line telephone on each level used for child care unless the cabinet has been notified that the telephone is temporarily out of service; and

Findings:

General: Based on Observation, it was found that the provider does not have a working land-line phone. The provider stated that her phone service is being switched to a different company and she is waiting for them to get her set up with new phone service.

265 - Emergency numbers **In Compliance**

(8) A certified family child-care home shall have:

(b) A list of emergency numbers posted by each telephone, including numbers for the:

1. Police;
2. Fire station;
3. Emergency medical care and rescue squad; and

270 - Stairs/Steps

Not In Compliance

922 KAR 2:100 - Section 11. The General Requirements of the Family Child-Care Home Environment.

(10) Stairs and steps used for children in care shall be:

- (a) Solid;
- (b) Safe; and
- (c) Railed.

Findings:

General: Based on Observation, it was found that the steps leading to the upstairs area of the home were not blocked. The provider stated that she noticed that the stairs were not blocked and put the gate up so the toddler children would not go upstairs.

275 - Stairs Blocked, if applicable

In Compliance

922 KAR 2:100 - Section 11. The General Requirements of the Family Child-Care Home Environment.

(11) If an infant or toddler is in the care of a provider, indoor stairs with more than two (2) steps shall be blocked.

280 - 35 Square Feet

(12) Exclusive of the bathroom and storage area, an indoor area, including furnishings, used for child care shall contain at least thirty-five (35) square feet per child for:

Findings:

General: Based on Observation, it was found that there were several areas of chipped paint on the walls and holes in the walls in the play room. It was also found that the rug in the play area was covered in dirt and debris. The floor in the bathroom was covered in brown stains. It was also found that the two (2) doors leading to the back yard were covered in brown stains. It was also found that there was dust caked on the ceiling fan in the play area. The provider stated that she would make sure these areas are cleaned.

290 - Water supply

In Compliance

922 KAR 2:100 - Section 11. The General Requirements of the Family Child-Care Home Environment.

(21) A family child-care home shall:

- (d) Have a water supply that is:
 1. Potable;
 2. Adequate; and
 3. From an approved public water supply;

295 - Bathroom sanitary

(21) A family child-care home shall:

- (e) Have bathrooms, including toilets, sinks, and potty chairs that are:
 1. Sanitary; and
 2. In good working condition.

300 - Openings Screened

(22) Windows, doors, and outer openings shall be screened to prevent the entrance of vermin.

305 - Garbage Stored Appropriately

(23) Indoor and outdoor garbage shall be stored in a waterproof container with a tight-fitting cover.

310 - Toilet Room

(1) A toilet room shall:

- (a) Have an adequate supply of toilet paper; and
- (b) Be cleaned and sanitized daily.

 - (a) Located in or immediately adjacent to toilets;
 - (b) Equipped with hot and cold running water that allows for hand washing;
 - (c) Equipped with hot water at a minimum temperature of ninety (90) degrees Fahrenheit and a maximum of 120 degrees Fahrenheit;
 - (d) Equipped with liquid soap and single use, disposable hand drying material;
 - (e) Equipped with an easily cleanable, covered waste receptacle; and
 - (f) Immediately adjacent to a changing area used for infants and toddlers.

Findings:

General: Based on Observation, it was found that the water temperature at the sink used by the children for handwashing, registered at 130 degrees.

320 - Toilet

Not In Compliance

922 KAR 2:100 - Section 13. Toilet and Diapering Requirements.

- (3) Each toilet shall:
 - (a) Be kept in clean condition;
 - (b) Be kept in good repair;
 - (c) Be in a lighted room; and
 - (d) Have ventilation.

Findings:

General: Based on Observation, it was found that there were feces in the toilet and stains around the inside of the toilet. The provider stated that one of the children had used the restroom and didn't flush.

325 - Sick Child Area

In Compliance

- (7) A quiet, separate area that is easily supervised shall be provided for a child too sick to remain with other children.

Hygienic Practices

330 - Child Handwashing

Not In Compliance

922 KAR 2:100 - Section 12. Care Requirements for a Provider.

- (4) A child shall wash hands with liquid soap and warm running water:
 - (a) Before and after eating or handling food;
 - (b) After toileting or diaper change;
 - (c) After handling animals;
 - (d) After wiping or blowing nose;
 - (e) After touching items soiled with body fluids or waste; and
 - (f) After outdoor and indoor play time.

Findings:

General: Based on Observation, the children did not wash their hands after coming in from outdoor play or after indoor play time.

335 - Adult hand washing

In Compliance

922 KAR 2:100 - Section 12. Care Requirements for a Provider.

- (5) A provider and an assistant shall:
 - (a) Wash hands with liquid soap and warm running water:
 1. Before and after diapering a child;
 2. Before and after feeding a child;
