(14) Each child in an outdoor play area shall be under the direct supervision of the provider or assistant.

Findings:

General: Based on Observation, it was found upon the surveyors' arrival a group of eight (8) children were outside playing in the certified provider's backyard. The surveyors called the certified provider's name several times and she did not come to the wooden gate on the playground and she was not observed. Several children came over to the gated area and the children stated that Ms. Margaret was inside the house. The children were outside unsupervised for approximately four (4) minutes. The surveyors went around to the front door of the home. The certified provider brought the children in the house prior to answering the front door. The certified provider indicated that a child had an accident and she was on the deck outside changing the child.

General: Based on Observation, the main floor level of the home, that is used for child care, did not contain a carbon monoxide detector. The certified provider indicated that the home is heated with gas. The certified provider indicated that she has a carbon monoxide detector in the basement, but the basement is not used for child care.

235 - 2 Unblocked Exits
