922 KAR 2:120. Section 10. Toilet, Diapering, and Toiletry Requirements.

(4) Each toilet shall:

- (a) Be kept in clean condition;**
- (b) Be kept in good repair;**
- (c) Be in a lighted room; and**
- (d) Have ventilation to outside air.**

Findings:

General: Based on observation, the surveyor found the following:

- (1.) A toilet seat was not securely fastened on a toilet in the Girls' Restroom; therefore, the toilet was not in good repair.
- (2.) A toilet seat was not securely fastened on a toilet in the Boys' Restroom; therefore, the toilet was not in good repair.
