Includes the center's discontinuation or disqualification from a governmental assistance program due to fraud, abuse, or criminal conviction related to that program;</b></li> </ol> <p><b>(d) An incident involving fire or other emergency, including a vehicular accident when the center is transporting a child receiving child care services;</b></p> <p><b>(e) A report of child abuse or neglect that:</b></p> <ol style="list-style-type: none"> <li><b>1. Has been accepted by the cabinet in accordance with 922 KAR 1:330; and</b></li> <li><b>2. Names a director, employee, volunteer, or person with supervisory or disciplinary control over, or having unsupervised contact with, a child in care as the alleged perpetrator; or</b></li> </ol> <p><b>(f) An individual specified in Section 6(4) of this administrative regulation meeting a disqualifying criterion or background check result pursuant to 922 KAR 2:280.</b></p>	
<b>Findings:</b>	
<p>General: Based on interview with staff-in-charge, the surveyor found that the accident/injury that occurred on 03/29/2021 was not reported within twenty-four (24) hours from the time of discovery.
