General: Based on review of documentation, interviews, the provider cared for seven (7) children from 7:15 a.m. until 3:00 p.m. on 11/10/14; nine (9) children from 8:00 a.m. until 2:00 p.m. on 11/11/14; nine (9) children from 8:00 a.m. until 3:15 p.m. on 11/12/14; eight (8) children from 7:30 a.m. until 3:10 p.m. on 11/13/14; eight (8) children from 7:45 a.m. until 2:45 p.m. on 11/14/14; eight (8) children from 8:00 a.m. until 3:00 p.m. on 11/03/14; ten (10) children from 7:45 a.m. until 2:30 p.m. on 11/04/14; eight (8) children from 8:00 a.m. until 3:00 p.m. on 11/05/14; eight (8) children from 8:00 a.m. until 1:15 p.m. on 11/06/14, and seven (7) children from 7:30 a.m. until 3:00 p.m. on 11/07/14. The assistant was the lone caregiver present who supervised the children while the provider was in Nashville, Tn. on 01/28/15.

The assistant was the lone caregiver present who supervised the children while the provider was in Nashville, Tn. on 01/28/15.

The assistant stated she was not aware of the exact time the provider left but she would return by 2:30 p.m. on 01/28/15.

**922 KAR 2:100 - Section 16. Animals.**

(1) An animal shall not be allowed in the presence of a child in care:

- (a) Unless:
    - 1. The animal is under the supervision and control of an adult;
    - 2. Written parental consent has been obtained; and
    - 3. The animal is certified as vaccinated against rabies; or
  - (b) Except in accordance with subsection (3) of this section.
- (2) A parent shall be notified in writing if a child has been bitten or scratched by an animal.
- (3) An animal that is considered undomesticated, wild, or exotic shall not be allowed at a certified family child-care home unless the animal is:
- (a) A part of a planned program activity led by an animal specialist affiliated with a zoo or nature conservatory; and
  - (b) In accordance with 301 KAR 2:081 and 301 KAR 2:082.
