 - 4. Copy of negative tuberculin results or a health professional's statement documenting that the adult is free of tuberculosis. Every two (2) years, the adult shall provide negative tuberculin results or health professional's statement documenting that the adult is free of tuberculosis.
- (b) An address check of the Sex Offender Registry conducted on behalf of the applicant for a Type II child-care center and supporting documentation shall indicate that no individual residing in the household is a registered sex offender.

Findings:

General: Based on observation, a Fisher Price infant's swing electrical cord hung from an electrical outlet to the side rails of a seven month old's crib in the nursery room #1. Also, a Crockpot was on a table and spewed water and steam onto a wall in nursery room #2. An infant was in a bouncy seat on the floor approximately four (4) feet from the Crockpot. Interview determined the Crockpot would remain on high temperature for the remainder of the day.

2. Criminal records check required by KRS 199.896(19);
3. Criminal records check for any previous state of residence if the person resided outside the state of Kentucky in the last five (5) years; and
4. An address check of the Sex Offender Registry; and

(c) Not be left alone in the presence of a child until copies of the background checks in accordance with paragraph (b) of this subsection have been received by the licensee.

Findings:

General: Based on review of documentation, a caregiver hired 3/12/14, did not have proof a child abuse/neglect check was submitted timely and this caregiver had been employed over ninety (90) days. A caregiver hired 4/19/14, a caregiver hired 6/16/14, and two (2) caregivers hired 4/25/14, did not have proof a child abuse/neglect check had been submitted timely. A caregiver hired 6/4/14 and a caregiver hired 5/27/14, did not have proof a criminal records check and a child abuse/neglect check were submitted timely.

305 - Background checks/discharged

(c) An individual who is confirmed by an address check of the Sex Offender Registry and supporting documentation as a registered sex offender;

(d) An individual who has been convicted of, or entered an Alford plea or plea of guilty to, a drug-related felony, and five (5) years has not elapsed since the person was fully discharged from imprisonment, probation, or parole;

(e) A director who has been convicted of, or entered an Alford plea or a plea of guilty to, a felony offense involving fraud, embezzlement, theft, or forgery; and

(f) An individual who has been convicted of, or has entered an Alford plea or a plea of guilty to, an offense under a criminal statute of the United States or of another state similar to an offense specified in this subsection.

(7) An individual who has been convicted of, or entered an Alford plea or a plea of guilty to, a nonviolent felony or misdemeanor not specified in this section shall be handled on a case-by-case basis by the licensee with consideration given to the:

- (a) Nature of the offense;

(b) Length of time that has elapsed since the event; and

General: Based on review of documentation, a caregiver hired 4/23/13, did not maintain have a child abuse/neglect check on file. Also, two (2) caregivers hired 8/25/12 and 2/26/13, did not maintain their documentation of education.

315 - Educational Requirements

General: Based on review of documentation, a caregiver hired 4/19/14, a caregiver hired 6/27/13, a caregiver hired 6/16/14, a caregiver hired 6/4/14, a caregiver 5/27/14, and a caregiver hired 4/25/14, did not have educational verification available for review.

320 - TB Verification

- 1. A statement from a health professional that the individual is free of active tuberculosis; or**

Findings:

General: Based on review of documentation, a caregiver hired 8/28/12, had a TB skin test dated 8/18/11; a caregiver hired 6/21/10, had a TB skin test dated 6/16/12; a caregiver hired 5/3/12, had a TB skin test dated 8/9/11; a caregiver hired 3/22/11, had a TB skin test dated 9/15/11; a caregiver hired 5/28/13, had a TB skin test dated 1/23/12; a caregiver hired 4/18/95, had a TB skin test dated 5/9/12, and a caregiver hired 8/27/13, had a TB skin test dated 11/21/11. In addition, two (2) caregivers hired 4/9/12 and 10/23/13 did not have TB documentation on file.
