The surveyor learned that eight (8) of the staff's most current annual performance evaluations were dated 01/24/12, one (1) staff's most current annual performance evaluation was dated 02/24/12 and one (1) staff's most current performance evaluation was dated 03/15/12. None of the staff's most current annual performance evaluations were conducted within timeframes to meet regulatory compliance.
