 - 4. Copy of negative tuberculin results or a health professional's statement documenting that the adult is free of tuberculosis. Every two (2) years, the adult shall provide negative tuberculin results or health professional's statement documenting that the adult is free of tuberculosis.
- (b) An address check of the Sex Offender Registry conducted on behalf of the applicant for a Type II child-care center and supporting documentation shall indicate that no individual residing in the household is a registered sex offender.

General: Based on Review of Documentation, the provider's husband who lives in the home did not have a child abuse/neglect check (CAN) and T.B. documentation on file.

 - 2. Criminal records check required by KRS 199.896(19);
 - 3. Criminal records check for any previous state of residence if the person resided outside the state of Kentucky in the last five (5) years; and
 - 4. An address check of the Sex Offender Registry; and
 - (c) Not be left alone in the presence of a child until copies of the background checks in accordance with paragraph (b) of this subsection have been received by the licensee.

305 - Background checks/discharged

In Compliance

922 KAR 2:090. Section 6. License Issuance.

- (6) Upon completion of background checks described in subsection (4)(b) of this section, a licensee shall discharge immediately:
- (a) An individual whose name is listed on the central registry established by 922 KAR 1:470;
 - (b) An individual who has been convicted of, or has entered an Alford plea or a plea of guilty to, a crime in accordance with KRS 17.165;
 - (c) An individual who is confirmed by an address check of the Sex Offender Registry and supporting documentation as a registered sex offender;
 - (d) An individual who has been convicted of, or entered an Alford plea or plea of guilty to, a drug-related felony, and five (5) years has not elapsed since the person was fully discharged from imprisonment, probation, or parole;
 - (e) A director who has been convicted of, or entered an Alford plea or a plea of guilty to, a felony offense involving fraud, embezzlement, theft, or forgery; and
 - (f) An individual who has been convicted of, or has entered an Alford plea or a plea of guilty to, an offense under a criminal statute of the United States or of another state similar to an offense specified in this subsection.
- (7) An individual who has been convicted of, or entered an Alford plea or a plea of guilty to, a nonviolent felony or misdemeanor not specified in this section shall be handled on a case-by-case basis by the licensee with consideration given to the:
- (a) Nature of the offense;
 - (b) Length of time that has elapsed since the event; and
 - (c) Individual's life experiences after conviction, Alford plea, or guilty plea.

Findings:

General: Based on Review of Documentation, interview and observation, the facility failed to maintain staff files. The staff person in charge (hire date: 11/17/05) was observed working alone with seven (7) children on the day of the survey. A review of this staff person's file found no evidence or results of a child abuse/neglect check (CAN). The staff person in charge stated that a CAN check had been processed; however, she was unable to locate the documentation during the visit. The staff person in charge stated that she is the only staff person currently employed at the facility.

315 - Educational Requirements

(4) For a child-care center licensed for school-age children, at least one (1) person on duty and present with the children shall be currently certified by a cabinet-approved training agency in the following skills:
(a) Adult cardiopulmonary resuscitation; and
(b) First aid.

330 - Adequate Substitute(s)

(6) Child-care centers shall have available in case of need:
(a) One (1) qualified substitute staff person for a Type II child-care center; or

Findings:

General: Based on Interview, this regulatory requirement was not met. The staff person in charge stated that she was the only staff person currently working at the facility and indicated that she did not have a substitute staff person.

335 - Qualified Substitute

(7) Each qualified substitute staff person shall:
(a) Meet the staff requirements of this administrative regulation; and
(b) Provide the required documentation to verify compliance with this administrative regulation.



340 - Training

 - (b) Nine (9) hours of cabinet-approved early care and education training within the first year of employment, including one and one-half (1 ½) hours of pediatric abusive head trauma training; and**
 - (c) Fifteen (15) hours of cabinet-approved early care and education training during each subsequent year of employment, including one and one-half (1 ½) hours of pediatric abusive head trauma training completed once every five (5) years.**

Findings:

General: Based on Review of Documentation, one (1) staff file (hire date: 11/17/05) did not contain the required fifteen (15) hours of training. It is important to note that this regulatory violation was previously issued on this same staff person as a result of relicensure surveys conducted on 7/25/13 and 8/1/12. The director had indicated on a Plan of Correction submitted 10/14/13 that she would complete the required training hours and stated, "I have enrolled with KET, this will make things a lot easier to take courses online. I will take the courses and post my certificate on the wall with my license in order to see the hours already received and keep me on target. This will keep me in compliance with regulations".

Two (2) children (enrollment date: 9/26/11) that were identified as siblings shared the same enrollment paper; therefore, they did not have individual records on file. 2. Two (2) children that were present in the facility on the day of the inspection had no identifying information or enrollment paperwork on file; therefore, none of the required information had been obtained. The staff person in charge identified one (1) of the children as her ten (10) year old son and the other child as being a ten (10) month old sibling of two (2) other children enrolled at the facility.
