General: Based on observation, three (3), four (4) year old children went into a stalled restroom unsupervised. The supervising caregiver stood at the door of the four (4) year olds' classroom and could not supervise what the three (3) children were doing in the restroom. These children were in the restroom for less than five (5) minutes. One (1) child played behind a Christmas tree located in the hallway, next to the door of the four (4) year olds' classroom.
