Director Requirements

265 - Health, Safety, Comfort

Not In Compliance

922 KAR 2:110. Section 4. Director Requirements and Responsibilities.

(1) Effective with the adoption of this administrative regulation, a director shall:

(l) Provide for the health, safety, and comfort of each child;

Findings:

General: Based on Interview and review of documentation, the child care director failed to assure regulatory compliance regarding the health, safety and comfort of a child. Interviews revealed that a six-year-old child had been placed in a hold, restricting movement of his arms and legs. While in the hold, the child struggled to get loose, which resulted in a bruise on his upper right thigh. Review of childcare behavior management/guidance techniques revealed the childcare center policies do not address the use of physical holds.
