 - (c) Not be left alone in the presence of a child until copies of the background checks in accordance with paragraph (b) of this subsection have been received by the licensee.

Findings:

General: Based on Review of Documentation, there was one (1) staff person hired 5/16/13 who did not have the results of a criminal records check and child abuse and neglect check on file at the facility. There was no evidence on file to verify the application for both records check had been submitted. This same staff person was observed supervising a group of eight (8) children ages two (2) to five (5) years old alone.

305 - Background checks/discharged

Findings:

General: Based on Review of Documentation, there was one (1) staff person hired 1/3/13 who did not have a copy of a high school diploma, GED or other qualifying documentation on file at the time of the visit.

320 - TB Verification

General: Based on Review of Documentation, there was one (1) staff person hired 12/2/08 who did not have a current T.B. skin test or statement from a health professional indicating the individual is free from the symptoms of T.B. on file at the facility. There was an additional staff person hired 1/3/13 who had the results of a T.B. test read on 7/6/13. This was done after employment.

325 - CPR/First Aid Coverage

General: Based on Review of Documentation, it was found that from 4:30-5:30 p.m. Wednesday -Friday each week there is no one at the facility who is currently certified in adult/child and infant CPR/FA.
