 4. A copy of negative tuberculin results or a health professional's statement documenting that the adult is free of tuberculosis. Every two (2) years, the adult shall provide negative tuberculin results or health professional's statement documenting that the adult is free of tuberculosis.
- (b) An address check of the Sex Offender Registry conducted on behalf of the applicant for a Type II child-care center and supporting documentation shall indicate that no individual residing in the household is a registered sex offender.

- (b) May be employed or work with a child on a probationary basis for up to ninety (90) calendar days, pending completion of a:
1. Child abuse or neglect check using the central registry in accordance with 922 KAR 1:470;
 2. Criminal records check required by KRS 199.896(19);
 3. Criminal records check for any previous state of residence if the person resided outside the state of Kentucky in the last five (5) years; and
 4. An address check of the Sex Offender Registry; and
- (c) Not be left alone in the presence of a child until copies of the background checks in accordance with paragraph (b) of this subsection have been received by the licensee.

Findings:

General: Based on Review of Documentation and observation, a caregiver with the hire date of 6/7/13, was working alone with children and failed to have a completed Child Abuse and Neglect check. Based on review of documentation and observation, a caregiver with the hire date of 09/19/13 was working alone with children and failed to have a completed Child Abuse and Neglect Check and Criminal Records Check.

305 - Background checks/discharged

315 - Educational Requirements

General: Based on Review of Documentation, the caregiver with the hire date of 09/23/13 failed have a high school diploma, GED or qualifying documentation from a comparable educational entity, or Commonwealth Child Care Credential as described in 922 KAR 2:250.

320 - TB Verification

- (b) Nine (9) hours of cabinet-approved early care and education training within the first year of employment, including one and one-half (1 ½) hours of pediatric abusive head trauma training; and**
- (c) Fifteen (15) hours of cabinet-approved early care and education training during each subsequent year of employment, including one and one-half (1 ½) hours of pediatric abusive head trauma training completed once every five (5) years.**

Findings:

General: Based on Review of Documentation, caregivers with the following hire dates, 06/07/13, 07/02/12, and 05/23/13 failed to complete the six hours of Cabinet-approved orientation training within three months of employment. Based on review of documentation, caregivers with the following hire dates: 01/05/13, 05/18/09, 03/18/10, 11/16/09, 01/05/09, 02/15/13, 01/05/07, 03/09/12, 05/14/12, and 01/05/09 each failed to have the total fifteen hours of cabinet approved child development training for each subsequent year of employment.

345 - Driver Requirements

(18) A driver of a vehicle transporting a child for a center shall:

In the K-1 Room, the futon frame was broken and the cushion cover was unclean, the rug with circles was unclean and was torn at the edge of the seam, and a wooden cabinet door was cracked and in disrepair.
