General: Based on Review of Documentation, there was one (1) staff person with a hire date of 8/18/11 who had the results of a criminal records check dated 10/19/11. KRS 199.896 states, "Application for the criminal record of a probationary employee shall be made no later than the date probationary employment begins." The date completed is after the hire date. There was no evidence on file to verify the criminal records check had been submitted prior to or on the date of hire. A review of records also found that the child abuse or neglect check had not been filled out by the staff person until 9/20/11. 922 KAR 1:470 requires that application for the child abuse or neglect records check be submitted within five (5) days of hire.

It was also found that a substitute hired 8/18/11 did not have a T.B. skin test done until 11/21/11. This does not meet the requirement of the regulation because it was completed after the date of hire and not prior to employment.
