#### Findings:

General: Based on Interview, it was found that the program uses nineteen (19) classrooms in addition to the gym, library, art room, the cafeteria and a portable unit located outside. A review of documentation from the initial inspection conducted on 5/28/09 found the facility was approved for the use of seventeen (17) classrooms, the gym, library, cafeteria, art room and computer lab. After reviewing the list of classrooms approved during the initial inspection and reviewing the list of classrooms currently being used by the program it was found that eight (8) of the nineteen classrooms and the portable unit have not been approved as part of the licensed space. It was also found that seven (7) classrooms that were approved for use during the initial inspection on 5/28/09 are not currently being used by the program. An interview with the school administrator found that some of the classrooms had been changed due to the school hiring new teachers.

General: Based on Review of Documentation, it was found that the files for seven (7) eligible employees did not contain evidence of an annual performance evaluation being conducted. The principal of the school stated that the former director got rid of a lot of the required paperwork.

#### Findings:

General: Based on Review of Documentation, it was found there were seven (7) staff present at the time of the survey who did not have the results of a child abuse or neglect check on file nor was there evidence that the application for the results of the child abuse or neglect check had been submitted. All seven (7) if these staff were observed supervising children alone or paired with another staff person who also did not have the results of a child abuse or neglect check on file at various times throughout the course of the survey. These staff were observed escorting children from a classroom down the hall to the cafeteria to go home with their parents. These staff were also observed supervising the children alone or paired with another staff person who did not have the results of a child abuse or neglect check in various classrooms. The hire dates for these staff are as follows; 8/24/15, 8/7/15, 8/17/15, 12/7/15, 9/8/15 and 12/7/15. In addition there were five (5) additional staff who were not present at the time of the survey but did not have the results of a child abuse or neglect check nor was there evidence on file to verify the application for the results of the child abuse or neglect check had been submitted. The hire dates for these staff are 12/4/15, 8/17/15, 8/11/15, 8/17/15, 8/11/15 and 10/4/15. An interview with the staff person in charge confirmed that one (1) of the staff hired 8/11/15 only works on Thursdays and Fridays and supervises children alone in the portable unit located outside. It was also found that the other staff who were not present at the time of the survey and did not have the results of the child abuse or neglect check also have been left to supervise children alone or have worked with another staff person who also did not have the results of a child abuse and neglect check on file.

Findings:

General: Based on Review of Documentation, it was found that 1) the file for an employee hired on 8-11-15 did not contain evidence of submission for or a completed criminal records check and central registry check; 2) the files for twelve employees hired within the last five months did not contain evidence of submission for or completed central registry checks. The school principal and the staff person in charge stated that they were unaware of the need to have central registry checks completed. Seven of the above mentioned employees were observed to be working alone with children during the survey. During interview with the staff person in charge and the school principal, it was found that all employees, including the ones not observed the day of the survey, work alone with the children at some point during their shift.

(d) An individual who has been convicted of, or entered an Alford plea or plea of guilty to, a drug-related felony, and five (5) years has not elapsed since the person was fully discharged from imprisonment, probation, or parole;

(e) A director who has been convicted of, or entered an Alford plea or a plea of guilty to, a felony offense involving fraud, embezzlement, theft, or forgery; and

(f) An individual who has been convicted of, or has entered an Alford plea or a plea of guilty to, an offense under a criminal statute of the United States or of another state similar to an offense specified in this subsection.

The principal of the school had to go to the school's main office to print out the information; 5) the file for one employee hired on 8-11-15 did not contain her date of birth. The school principal stated that the former director got rid of much of the required documentation and that they have not yet learned what needed to be in the files.

In addition the staff person in charged was asked about materials used to assure all areas required in the regulations are kept and it was stated they are kept on the stage. Those items were viewed by the surveyor at the time of the visit. Interviews with staff found that the children only have access to the materials from 5:30-6:00 p.m. two (2) to three (3) days a week. It was also found that each group has access to the gym one (1) day a week. Although there is a playground located outside, the groups who did not have access to the gym that day were not observed using the playground. An interview with one (1) the staff stated that for gross motor time her group was playing the game Hangman while using one (1) of the classrooms.

For example one group listed they had conducted a fire drill, tornado drill and an earthquake drill on the same date at 5:02 p.m. The Neil Armstrong group did not document the time the tornado and earthquake drills were conducted for August and September 2015 nor did they have documentation verifying the names of the children who were present when the drills were conducted. The Lewis and Clark group only had the names of the children and the date the earthquake and tornado drills were conducted for August and September and October 2015. There were no times listed. An interview with school personnel indicated there will be changes made as to how drills are conducted and documented.
