General: Based on review of documentation, the file presented for surveyor review for a volunteer (start date: 9/1/12) did not contain evidence of a completed child abuse and neglect check or criminal records check. The director stated during interview that both background checks were completed for this individual but the background checks were not presented for surveyor review at the time of the inspection and the individual has volunteered for more than ninety (90) calendar days.

The director stated during interview that a child abuse and neglect check was completed for this individual but the background check was not presented for surveyor review at the time of inspection. Therefore, it could not be verified that the check was submitted for completion within the time frame required by 922 KAR 1:470.

The director stated during interview that a criminal record check was submitted for completion for this individual but verification was not presented for surveyor review at the time of inspection. Therefore, it could not be verified that the background check was submitted for completion within the time frame required by KRS 199.896(19).

(2) The file presented for surveyor review for a volunteer (start date: 9/1/12) did not contain evidence that a criminal record check has been submitted for completion. The director stated during interview that a criminal record check was completed for this individual but the background check was not presented for surveyor review at the time of inspection. Therefore, it could not be verified that the check was submitted for completion within the time frame required by KRS 199.896(19).
