 - 4. Copy of negative tuberculin results or a health professional's statement documenting that the adult is free of tuberculosis. Every two (2) years, the adult shall provide negative tuberculin results or health professional's statement documenting that the adult is free of tuberculosis.
- (b) An address check of the Sex Offender Registry conducted on behalf of the applicant for a Type II child-care center and supporting documentation shall indicate that no individual residing in the household is a registered sex offender.

155 - Staff Awake on Duty

Findings:

General: Based on review of documentation, staff evaluations were not presented for review.

Inspection Report

265 - Health, Safety, Comfort

Not In Compliance

922 KAR 2:110. Section 4. Director Requirements and Responsibilities.
(1) Effective with the adoption of this administrative regulation, a director shall:
(l) Provide for the health, safety, and comfort of each child;

Findings:

General: Based on observation, the following were found:

- 1) A four feet (4') tall shelf and a two feet (2') tall shelf in the One's Room were unsecured and tipped easily.
- 2) A three feet (3') tall tower heater and a three feet (3') tall shelf in the Infant Room were unsecured and wobbly.
- 3) A ten-month-old infant was seated in a high chair and safety straps were not used to secure the child.
- 4) A six-week-old infant was sleeping on a boppy pillow in a crib in the Infant Room. Staff stated that the infant's parent verbally requested that the infant sleep on the boppy pillow but that written documentation of this request was not provided by the parent.
- 5) Plastic sleeves containing documentation of crib compliance were secured to the top, and hung below the rails, of two (2) cribs in the Infant Room. The cribs were assigned to individual infants who were currently enrolled and attended the center.
- 6) An unsecured television was on a four and one-half feet (4 1/2') tall shelf in the Preschool Room.
- 7) A three feet (3') tall cubby was unsecured and tipped easily in the Preschool Room.
- 8) A toilet brush was beside a toilet in the Preschool Restroom.
- 9) A child's mat was placed below a wall shelf at nap time. An unsecured desk telephone was on the shelf and the phone cord hung below the shelf to within approximately two feet (2') of the floor and within a child's reach.
- 10) A staff member placed sheets and covers on the children's mats prior to nap time in the Preschool Room. The staff member smoothed and arranged the sheet with her shoe on one (1) child's mat and she stepped on two (2) other children's sheet and blanket covered mats.
- 11) Two (2) mouse traps were located on the floor in the hot water closet. The closet was accessed via a door in the School Age Restroom and was secured by a hook and eye latch. However, the eye section had pulled away from the wooden door frame allowing the door to remain ajar by approximately two inches (2").
- 12) An unsecured television was on a three feet (3') tall shelf in the School Age Room.
- 13) A bottle of Louisiana Hot Sauce was on a three feet (3') tall shelf in the Preschool Room.
- 14) An aerosol can of WD-40 was on a wall shelf in the hallway outside the director's office.
- 15) An electric outlet plate and a cover were missing on an electric outlet in the Overflow Room.
- 16) A tissue box containing debris including a tumb tack was on a cart in the School Age Room.

270 - Parent Notification

In Compliance

(1) Effective with the adoption of this administrative regulation, a director shall:
(m) Notify the parent immediately of an accident or incident requiring medical treatment of a child;

275 - Caregiver Alone

(1) Effective with the adoption of this administrative regulation, a director shall:
(n) Assure that a person acting as a caregiver of a child in care shall not be left alone with a child, if the licensee has not received the results of the background checks as described in Section 3(1)(e)6 of this administrative regulation;

Employee Records

300 - Background checks/left alone

922 KAR 2:090. Section 6. License Issuance.

- (5) An individual described in subsection (4) of this section shall:
- Submit to background checks described in paragraph (b) of this subsection;
 - May be employed or work with a child on a probationary basis for up to ninety (90) calendar days, pending completion of a:
 - Child abuse or neglect check using the central registry in accordance with 922 KAR 1:470;
 - Criminal records check required by KRS 199.896(19);
 - Criminal records check for any previous state of residence if the person resided outside the state of Kentucky in the last five (5) years; and
 - An address check of the Sex Offender Registry; and
 - Not be left alone in the presence of a child until copies of the background checks in accordance with paragraph (b) of this subsection have been received by the licensee.

Findings:

General: Based on review of documentation, the following was found:

- A criminal records check was not presented for review for a staff member (date of hire - 3/1/2013). Staff stated during interview that this individual is a teacher and that she works alone with the preschool age children.
- A criminal records check was not presented for review for a substitute staff member. A date of hire was also not provided. Staff stated during interview that this individual was employed through the school co-op program. Staff were unaware if this individual has resided outside of the Commonwealth of Kentucky in the last five (5) years.

305 - Background checks/discharged

- An individual whose name is listed on the central registry established by 922 KAR 1:470;
 - An individual who has been convicted of, or has entered an Alford plea or a plea of guilty to, a crime in accordance with KRS 17.165;
 - An individual who is confirmed by an address check of the Sex Offender Registry and supporting documentation as a registered sex offender;
 - An individual who has been convicted of, or entered an Alford plea or plea of guilty to, a drug-related felony, and five (5) years has not elapsed since the person was fully discharged from imprisonment, probation, or parole;
 - A director who has been convicted of, or entered an Alford plea or a plea of guilty to, a felony offense involving fraud, embezzlement, theft, or forgery; and
 - An individual who has been convicted of, or has entered an Alford plea or a plea of guilty to, an offense under a criminal statute of the United States or of another state similar to an offense specified in this subsection.
- (7) An individual who has been convicted of, or entered an Alford plea or a plea of guilty to, a nonviolent felony or misdemeanor not specified in this section shall be handled on a case-by-case basis by the licensee with consideration given to the:
- Nature of the offense;
 - Length of time that has elapsed since the event; and
 - Individual's life experiences after conviction, Alford plea, or guilty plea.

310 - Personnel File

- (1) A child-care center shall maintain:
- (e) A current personnel file for each child-care center staff person to include:
- Name, address, date of birth, and date of employment;
 - Proof of educational qualifications;
 - Record of annual performance evaluation;
 - Written record of training participation to include:
 - The training source;
 - Location;
 - Date; and
 - Number of clock hours completed;
 - Every two (2) years, a:
 - Statement from a health professional that the individual is free of active tuberculosis; or
 - Copy of negative tuberculin results; and
 - For a director, employee, volunteer, or any person with supervisory or disciplinary control over, or having unsupervised contact with, a child in care, the results of a:
 - Child abuse or neglect check using the central registry in accordance with 922 KAR 1:470;
 - Criminal records check required by KRS 199.896(19);
 - Criminal records check from any previous state of residence completed once if:
 - The individual resided outside the state of Kentucky in the last five (5) years; and
 - No criminal records check has been completed for the individual's previous state of residence; and
 - An address check of the Sex Offender Registry;

Findings:

General: Based on review of documentation, the following was found:

- The personnel file for one (1) substitute staff member did not include a beginning date of employment. Staff stated during interview that it was unknown when this individual began employment.
- A criminal records check, a child abuse or neglect check and a criminal records check from any previous state of residence were not presented for review for a volunteer. Staff stated during interview that they were unaware if this individual has resided outside of the Commonwealth of Kentucky in the last five years but that this individual has had no unsupervised contact with a child in care.

The Overflow Room and the Preschool Room were in one (1) large room and separated by five feet (5') tall shelves. Staff use the Overflow Room for storage of extra mats and for storage of milk for the preschool children's lunches. Staff were observed to access the Overflow room by pushing a shelf away to create an open area. Staff stated during interview that the room is currently not being used for child care but that it is being prepared for children's use beginning next week. Children were not observed in the room during the inspection.
