595 - Child Personal Care/Handwashing **Not In Compliance**

922 KAR 2:120. Section 3. General Requirements.

- (4) A child shall:**
- (a) Be helped with personal care and cleanliness based upon their developmental skills; and**
 - (b) Wash his or her hands with liquid soap and warm running water:**
 - 1. a. Upon arrival at the center; or**
 - b. Within thirty (30) minutes of arrival for school-age children;**
 - 2. Before and after eating or handling food;**
 - 3. After toileting or diaper change;**
 - 4. After handling animals;**
 - 5. After wiping or blowing nose;**
 - 6. After touching items soiled with body fluids or wastes; and**
 - 7. After outdoor or indoor play time.**

Findings:

General: Based on Interview, the surveyor found that toddlers ages fifteen to twenty-three (15-23) months enrolled in the Elephant and Monkey classrooms do not wash their hands upon arrival at the center, before and after handling food, and after diaper changes. Staff stated that they were unaware that children were required to wash their hands upon arrival. Staff stated that upon arrival, children go directly to centers and play. The surveyor inquired about hand-washing prior to breakfast, lunch, and snack. Staff stated that children go directly to the table to eat. The surveyor inquired about hand-washing after diaper changes. The staff stated that they use a wipe in place of soap and water.
