922 KAR 2:120. Section 2. Child Care Services.

(10) A child shall not be subjected to:

- (a) Corporal physical discipline pursuant to KRS 199.896(18);**
- (b) Loud, profane, threatening, frightening, or abusive language; or**
- (c) Discipline that is associated with:**
 - 1. Rest;**
 - 2. Toileting; or**
 - 3. Food.**

Findings:

General: Based on Interview and review of documentation, the child care center failed to comply with regulatory programming requirements. Interview with staff members revealed inappropriate discipline was used on a four-year-old child for hitting another child in care. Review of documentation revealed a staff member was terminated from the child care center on 5/23/16 for admitting to inappropriately disciplining a child.
