7 and older 1 staff for 25 children

(for before and after school) 30

1 staff for 20 children

(full day of care) 30

*Maximum Group Size shall be applicable only to Type I centers.

- (c) Fifteen (15) hours of cabinet-approved training during each subsequent year of employment.**
