It was reported that the child and teacher had gotten into an altercation which resulted into the scratch. It is important to note that the facility reported the incident to DRCC.</p>

The teacher was yelling "I'm tired of y'all crying" and "not sharing". It could not be determined which classroom this was coming from, but was in the front of the building on the top floor.</p>
