<b>Findings:</b>	
<p>General: Based on interview, this regulation was not met. A staff in the school age room did not know how to correctly discipline a child. She asked the child several times to stop throwing his shoes. When the child wouldn't listen, the staff took the shoe and tapped the child on the arm with it. The child care center must ensure that no one physically hurts a child in care. This includes pinching, hitting, swatting, thumping, smacking, spanking, etc.</p>
