General: Based on Observation the child care center director failed to assure compliance with regulatory requirements. In room 126, the Four year old room, there were two bottles of hand sanitizer on the teacher's desk.

(14) In accordance with KRS 199.896(15) and (16), a staff person with supervisory authority over a child shall complete the following: (a) Six (6) hours of cabinet-approved orientation within the first three (3) months of employment; (b) Nine (9) hours of cabinet-approved early care and education training within the first year of employment, including one and one-half (1 ½) hours of pediatric abusive head trauma training; and (c) Fifteen (15) hours of cabinet-approved early care and education training during each subsequent year of employment, including one and one-half (1 ½) hours of pediatric abusive head trauma training completed once every five (5) years.

General: Based on Review of Documentation the child care center failed to maintain employee records in accordance with regulatory requirements. Staff member with hire date 1/5/15 did not have required 15 hours of training.

- (g) Personal belongings and medications of staff.**

General: Based on Observation the child care center failed to maintain the premises in accordance with regulatory requirements. Located in the MDO room there were sharp scissors on a staff desk with sharp part pointing towards a child's cot.

- (c) Information on the Kentucky Consumer Product Safety Program and the program's website as specified in KRS 199.897;**
- (d) A description of services provided by the child-care center, including:
 - 1. Current rates for child care; and**
 - 2. Each service charged separately and in addition to the basic rate for child care;****
- (e) Minimum staff-to-child ratios and group size established in 922 KAR 2:120; and**
- (f) Daily schedule.**

Findings:

General: Based on Review of Documentation the child care center failed to post documentation in accordance with regulatory requirements. The most recent Statement of Deficiency was not posted or accessible to parents.
