Findings: General: Based on observation of video footage from 8/29/17, it was found that the staff member (DOH: 7/22/16) in the two-year-old classroom stepped out of the classroom area and into the hallway at 12:46pm and did not return to the classroom area until 12:57pm. Based on interview, it was reported that the staff member was doing laundry and was sitting on the floor of the hallway during this time. Further interviews determined that the staff member was unable to physically see all of the children in the classroom at this time. Therefore, the children were left unsupervised for a total of eleven (11) minutes.
