Findings:

General: Based on Observation, at 9:35am the surveyor observed a preschool child leave the bathroom area where her teacher and other children were and come into the eating area alone to retrieve a step stool to take back to the bathroom. For approximately thirty (30) minutes the preschool teacher wore headphones while interacting and working with the children. It is not certain if he had music on at the time but he was heard raising his voice several times with the children.

The check shall indicate that the adult has not been convicted of, or has not entered an Alford plea or a plea of guilty to, an offense under a criminal statute of the United States or of another state similar to an offense specified in subparagraph 1 of this paragraph; and
 - 4. Copy of negative tuberculin results or a health professional's statement documenting that the adult is free of tuberculosis. Every two (2) years, the adult shall provide negative tuberculin results or health professional's statement documenting that the adult is free of tuberculosis.**
- (b) An address check of the Sex Offender Registry conducted on behalf of the applicant for a Type II child-care center and supporting documentation shall indicate that no individual residing in the household is a registered sex offender.**

General: Based on Observation, the surveyor found a staff member and an infant in the church auditorium with the lights off. The staff member was sitting in a chair with the child standing next to her. There were no activities for the child and this area is not licensed space. It could not be determined how long they were in the unlicensed space.

 - (c) Not be left alone in the presence of a child until copies of the background checks in accordance with paragraph (b) of this subsection have been received by the licensee.

General: Based on Review of Documentation, staff member hired on 04/15 did not have a child abuse and neglect check on file or any documentation showing that the check had been submitted. This staff member was working alone with the children at the time of the survey. Staff member hired on 10/06/14 had a criminal records check dated 11/14/14. Substitute staff member hired on 05/08/15 did not have a criminal records check or child abuse and neglect check on file. She was not present the day of the survey.

305 - Background checks/discharged

 - A director who has been convicted of, or entered an Alford plea or a plea of guilty to, a felony offense involving fraud, embezzlement, theft, or forgery; and
 - An individual who has been convicted of, or has entered an Alford plea or a plea of guilty to, an offense under a criminal statute of the United States or of another state similar to an offense specified in this subsection.
- (7) An individual who has been convicted of, or entered an Alford plea or a plea of guilty to, a nonviolent felony or misdemeanor not specified in this section shall be handled on a case-by-case basis by the licensee with consideration given to the:
- Nature of the offense;
 - Length of time that has elapsed since the event; and
 - Individual's life experiences after conviction, Alford plea, or guilty plea.

 - The individual resided outside the state of Kentucky in the last five (5) years; and
 - No criminal records check has been completed for the individual's previous state of residence; and
 - An address check of the Sex Offender Registry;

315 - Educational Requirements

- (a) Hired after January 1, 2009, who have supervisory power over a minor and are not enrolled in secondary education, shall have a:
- High school diploma;
 - GED or qualifying documentation from a comparable educational entity; or

Findings:

General: Based on Review of Documentation, staff members hired on 04/15, 04/24/14, 02/02/14 and 05/08/15 did not have education documentation on file.

320 - TB Verification

- (1) Child-care center staff:
- (b) Shall provide, prior to employment and every two (2) years thereafter:
- A statement from a health professional that the individual is free of active tuberculosis; or
 - A copy of negative tuberculin results.

Findings:

General: Based on Review of Documentation, staff members hired on 02/02/14 and 05/08/15 did not have documentation from a health care professional stating they were free of active tuberculosis. Staff member hired on 10/06/14 had a TB skin test on file dated 10/21/14.

325 - CPR/First Aid Coverage

The menu for breakfast that day stated toast, apples and orange juice would be served. When asked what the children would be served for lunch a staff member stated pizza rolls and tater tots. The surveyor looked in the freezer and there were no pizza rolls or tater tots. The menu for lunch that day stated chicken alfredo, peas, wheat bread and milk would be served for lunch.
