- (24) Supports for climbing apparatus and large equipment shall be securely fastened to the ground.
- (25) Crawl spaces, such as tunnels, shall be short and wide enough to permit access by adults.
- (26) A sandbox shall be:
 - (a) Constructed to allow for drainage;
 - (b) Covered when not in use;
 - (c) Kept clean; and
 - (d) Checked for vermin prior to use.

General: Based on observation, a thirty-one (31) inch tall green/blue slide was not anchored to the ground in the outdoor play area.

General: Based on observation, the center failed to assure compliance with 922 KAR 2:415E. Two (2) stuffed body dolls, five (5) pillows, and a large stuffed bear were in the child care room. In addition, two (2) caregivers intermittently wore a face mask in the child care room.
