Findings:

General: Based on observation, surveyor arrived at the center at 10:10 a.m. on 1/22/14, the surveyor entered the dining/ school age room at 10:14 A.M. and observed nine (9) children, ages two (2) to four (4) years old had been left unsupervised while they sat in highchairs and at the tables. It was determined the preschool children were alone for approximately four (4) minutes. The infants' caregiver followed the surveyor to the preschool room and left three (3) infants' unsupervised for approximately (1) minutes.

Dining/school-age room: Based on observation and interview, nine (9) children were unsupervised from at least 10:10 a.m. to 10:14 a.m. on 01/22/14. The responsible caregiver went to the kitchen to prepare the lunch meal.

Findings:

922 KAR 2:090 Section 11(9) (b) states, The cabinet or its designee shall suspend the license if: the child care-center fails to comply with the approved corrective active plan. This center failed to comply with its written active plan as indicated below:

Review of records determined the center was cited a violation on 2/26/13, for inadequate supervised (Tag #167). An acceptable plan of correction was received on 7/12/13, stating, "To correct the violation will make sure to have staff to ratio present at all times. Had a meeting not to leave children alone without caregiver present."

The center was cited a violation on 2/27/12, for inadequate supervision at all times (Tag #167). An acceptable plan of correction was received on 5/23/12, stating, "To correct the violation made sure to have staff to ratios present at all time. Had a meeting about not reading the newspaper while watching the children. To correct violation had a meeting not to leave children alone without caregiver present."

Based on observation, at 10:10 a.m. on 1/22/14, the surveyor entered the dining/school age room at 10:14 A.M. and observed nine (9) children, two to four years old, had been left unsupervised while they sat in highchairs and at the tables. These children had been left alone from at least 10:10 a.m. until 10: 14 a.m. In addition, the infants' caregiver followed the surveyor to the preschool room and left three (3) infants' unsupervised for several minutes. The center is not following the approved corrective action plan.

Also, the center was cited on 2/26/13, for not ensuring enough staff were present during cooking (Tag #117). An acceptable plan of correction was received on 7/12/13 stating, "The specific action taken to correct, was to correct the violations will make sure additional staff are available during cooking to maintain staff to child ratios are met. Had a staff meeting with staff to have more staff available every day during cooking and feeding."

Based on observation and interview, nine (9) children were unsupervised while the caregiver went to the kitchen to prepare the lunch meal at 10:10 A.M. on 1/22/14. The center failed to follow the approved plan of correction.

 - 4. Copy of negative tuberculin results or a health professional's statement documenting that the adult is free of tuberculosis. Every two (2) years, the adult shall provide negative tuberculin results or health professional's statement documenting that the adult is free of tuberculosis.
- (b) An address check of the Sex Offender Registry conducted on behalf of the applicant for a Type II child-care center and supporting documentation shall indicate that no individual residing in the household is a registered sex offender.

305 - Background checks/discharged

 - (c) An individual who is confirmed by an address check of the Sex Offender Registry and supporting documentation as a registered sex offender;
 - (d) An individual who has been convicted of, or entered an Alford plea or plea of guilty to, a drug-related felony, and five (5) years has not elapsed since the person was fully discharged from imprisonment, probation, or parole;
 - (e) A director who has been convicted of, or entered an Alford plea or a plea of guilty to, a felony offense involving fraud, embezzlement, theft, or forgery; and
 - (f) An individual who has been convicted of, or has entered an Alford plea or a plea of guilty to, an offense under a criminal statute of the United States or of another state similar to an offense specified in this subsection.
- (7) An individual who has been convicted of, or entered an Alford plea or a plea of guilty to, a nonviolent felony or misdemeanor not specified in this section shall be handled on a case-by-case basis by the licensee with consideration given to the:
- (a) Nature of the offense;
 - (b) Length of time that has elapsed since the event; and
 - (c) Individual's life experiences after conviction, Alford plea, or guilty plea.

310 - Personnel File

315 - Educational Requirements
