922 KAR 2:120. Section 2. Child Care Services.
(3)(a) Each center shall maintain a child-care program that assures each child will be:
1. Provided with adequate supervision at all times by a qualified staff person who:
a. Ensures the child is within scope of vision and range of voice; or
b. For a school-age child, within scope of vision or range of voice;

Findings:

General: Based on Observation, and interview the child care center failed to maintain adequate supervision of infants, toddlers, and preschool age children. The following events were observed and the children were not within scope of vision of staff. Observation of the two-year-old classroom at 11:27am revealed two preschool age children in the two's classroom by themselves. The director was in the kitchen and walked in the two's classroom immediately after the surveyor arrived in the classroom. The director stated she was about to allow the infant teacher to stand between the classrooms to supervise the children in the infant's classroom and the children in the two's classroom. The staff member in the infant classroom walked into the hallway at 11:28am and left six (6) infants/toddlers in the infant classroom by themselves. The aforementioned staff member (DOH: 6/17/13) immediately went back into the infant's classroom when I informed her that the six (6) infants/toddlers are unsupervised. Observation of the space between the infant classroom and the two-year-old classroom revealed that each classroom is not within scope of vision of each other when standing in the hallway between the two classrooms. At 1:15 pm the surveyor was observing the kitchen and the infant teacher (DOH: 6/17/13) walked into the kitchen holding an infant and placed a bottle on top of the microwave. Observation of the infant classroom at 1:15 pm revealed four (4) infants sleeping without an adult in the classroom, in which the staff member immediately came back to the infant classroom when she observed the surveyor walk into the infant classroom.

Observation of the infant classroom at 11:11am revealed one staff member supervising six (6) children ages three-months-old to seventeen-months-old. Further observation of the infant classroom revealed that the classroom was out of ratio until 11:30am.

 - 4. Copy of negative tuberculin results or a health professional's statement documenting that the adult is free of tuberculosis. Every two (2) years, the adult shall provide negative tuberculin results or health professional's statement documenting that the adult is free of tuberculosis.**
- (b) An address check of the Sex Offender Registry conducted on behalf of the applicant for a Type II child-care center and supporting documentation shall indicate that no individual residing in the household is a registered sex offender.**

Review of documentation revealed the aforementioned staff member lived out of state within the last five (5) years. Continued review of documentation revealed the aforementioned staff member did not have an out of state criminal records check on file. Interview with the staff member revealed she lived out of state within the last three (3) years. Interview with the director revealed she has not submitted a request for an out of state criminal records check for the aforementioned staff member.

 - (e) A director who has been convicted of, or entered an Alford plea or a plea of guilty to, a felony offense involving fraud, embezzlement, theft, or forgery; and**
 - (f) An individual who has been convicted of, or has entered an Alford plea or a plea of guilty to, an offense under a criminal statute of the United States or of another state similar to an offense specified in this subsection.**
- (7) An individual who has been convicted of, or entered an Alford plea or a plea of guilty to, a nonviolent felony or misdemeanor not specified in this section shall be handled on a case-by-case basis by the licensee with consideration given to the:**
 - (a) Nature of the offense;**
