 - 3. Criminal records check for any previous state of residence completed once if:
 - a. The adult resided outside the state of Kentucky in the last five (5) years; and
 - b. No criminal records check has been completed for the adult's previous state of residence. The check shall indicate that the adult has not been convicted of, or has not entered an Alford plea or a plea of guilty to, an offense under a criminal statute of the United States or of another state similar to an offense specified in subparagraph 1 of this paragraph; and
 - 4. Copy of negative tuberculin results or a health professional's statement documenting that the adult is free of tuberculosis. Every two (2) years, the adult shall provide negative tuberculin results or health professional's statement documenting that the adult is free of tuberculosis.
- (b) An address check of the Sex Offender Registry conducted on behalf of the applicant for a Type II child-care center and supporting documentation shall indicate that no individual residing in the household is a registered sex offender.

155 - Staff Awake on Duty

Findings:

General: Based on Review of Documentation, and interview, the child care center director failed to assure compliance with regulatory requirements. Record review and interview with the child care center director revealed no documented evidence of a staff meeting conducted within the last year. The last documented staff meeting occurred on 08/18/14.

260 - Staff Evaluation

In Compliance

922 KAR 2:110. Section 4. Director Requirements and Responsibilities.

- (1) Effective with the adoption of this administrative regulation, a director shall:
- (j) Assess each staff person's interaction with children in care and classroom performance through an annual written performance evaluation;

Findings:

General: Based on Review of Documentation, and observation, the child care center director failed to assure compliance with regulatory requirements. Employee record review revealed the child care center director failed to conduct an out-of-state Criminal Records Background Check for an employee with a hire date of 05/26/15. Review of employee's Child Abuse and Neglect Check revealed the employee resided in the state of Indiana within the last five (5) years. Observation on 10/13/15 at 10:23 AM revealed the employee was allowed to work alone with four (4) infant/toddlers without a completed out-of-state Criminal Records Background Check and remained alone throughout the inspection.

280 - Altered/Falsified Records

 - (o) Assure each mandatory record specified in Section 3 of this administrative regulation has not been altered or falsified;

 - (c) Not be left alone in the presence of a child until copies of the background checks in accordance with paragraph (b) of this subsection have been received by the licensee.

Findings:

General: Based on Review of Documentation, and observation, the child care center failed to maintain employee records in accordance with regulatory requirements. Employee record review revealed child care center employee with a hire date of 05/26/15 failed to complete an out-of-state Criminal Records Background Check for the state of Indiana. Review of employee's Child Abuse and Neglect Check revealed the employee resided in the state of Indiana within the last five (5) years. In addition, the employee was observed to work alone in the infant room on 10/13/15 at 10:23 AM with four (4) infant/toddlers.

305 - Background checks/discharged

 - (c) An individual who is confirmed by an address check of the Sex Offender Registry and supporting documentation as a registered sex offender;
 - (d) An individual who has been convicted of, or entered an Alford plea or plea of guilty to, a drug-related felony, and five (5) years has not elapsed since the person was fully discharged from imprisonment, probation, or parole;
 - (e) A director who has been convicted of, or entered an Alford plea or a plea of guilty to, a felony offense involving fraud, embezzlement, theft, or forgery; and
 - (f) An individual who has been convicted of, or has entered an Alford plea or a plea of guilty to, an offense under a criminal statute of the United States or of another state similar to an offense specified in this subsection.
- (7) An individual who has been convicted of, or entered an Alford plea or a plea of guilty to, a nonviolent felony or misdemeanor not specified in this section shall be handled on a case-by-case basis by the licensee with consideration given to the:
 - (a) Nature of the offense;
 - (b) Length of time that has elapsed since the event; and
 - (c) Individual's life experiences after conviction, Alford plea, or guilty plea.

315 - Educational Requirements

General: Based on Review of Employee records and interview, the child care center failed to maintain employee records in accordance with regulatory requirements. Employee record review revealed child care center employees with hire dates of 12/01/11, 06/17/13, 01/01/12 and 12/01/11, failed to complete fifteen (15) hours of cabinet-approved early child and education training during the previous year of employment. Interview with the child care center director revealed these trainings were incomplete.
