- (b) An address check of the Sex Offender Registry conducted on behalf of the applicant for a Type II child-care center and supporting documentation shall indicate that no individual residing in the household is a registered sex offender.

General: Based on Interview, the director stated that staff meetings are conducted, but they are not documented.

(1) Effective with the adoption of this administrative regulation, a director shall:

(j) Assess each staff person's interaction with children in care and classroom performance through an annual written performance evaluation;

Findings:

General: Based on Interview, staff evaluations have not been completed on any staff members within the past year that reflect how they interact with the children.

265 - Health, Safety, Comfort**Not In Compliance****922 KAR 2:110. Section 4. Director Requirements and Responsibilities.**

(1) Effective with the adoption of this administrative regulation, a director shall:

(l) Provide for the health, safety, and comfort of each child;

Findings:

General: Based on Observation, a smoke detector is beeping in the kitchen area indicating the batteries are low. Further observation revealed a toilet brush in the bathroom that is accessible to children.

270 - Parent Notification**In Compliance****922 KAR 2:110. Section 4. Director Requirements and Responsibilities.**

(1) Effective with the adoption of this administrative regulation, a director shall:

(m) Notify the parent immediately of an accident or incident requiring medical treatment of a child;

(1) Effective with the adoption of this administrative regulation, a director shall:

(n) Assure that a person acting as a caregiver of a child in care shall not be left alone with a child, if the licensee has not received the results of the background checks as described in Section 3(1)(e)6 of this administrative regulation;

300 - Background checks/left alone

Not In Compliance

922 KAR 2:090. Section 6. License Issuance.

- (4) A director, employee, volunteer, or any person with supervisory or disciplinary control over, or having unsupervised contact with, a child shall:
 - (a) Submit to background checks described in paragraph (b) of this subsection;
 - (b) May be employed or work with a child on a probationary basis for up to ninety (90) calendar days, pending completion of a:
 - 1. Child abuse or neglect check using the central registry in accordance with 922 KAR 1:470;
 - 2. Criminal records check required by KRS 199.896(19);
 - 3. Criminal records check for any previous state of residence if the person resided outside the state of Kentucky in the last five (5) years; and
 - 4. An address check of the Sex Offender Registry; and
 - (c) Not be left alone in the presence of a child until copies of the background checks in accordance with paragraph (b) of this subsection have been received by the licensee.

Findings:

General: Based on Observation, an employee with the hire date of 06/17/2013 does not have a completed out of state Criminal Record Check from Alabama. Interview with that employee revealed that she resided in Alabama less than two years ago. Interview with director revealed that the staff member does not work alone. Further review of documentation revealed that employees with the hire dates of 06/17/2013 and 07/31/2013 did not have a Criminal Record Check (CRC) completed until 10/10/2013, therefore, the center did not submit the CRC request on the initial date of hire.

305 - Background checks/discharged

 - 1. Name, address, date of birth, and date of employment;

 - a. The training source;
 - b. Location;
 - c. Date; and
 - d. Number of clock hours completed;
 - 5. Every two (2) years, a:
 - a. Statement from a health professional that the individual is free of active tuberculosis; or
 - b. Copy of negative tuberculin results; and
 - 6. For a director, employee, volunteer, or any person with supervisory or disciplinary control over, or having unsupervised contact with, a child in care, the results of a:
 - a. Child abuse or neglect check using the central registry in accordance with 922 KAR 1:470;
 - b. Criminal records check required by KRS 199.896(19);
 - c. Criminal records check from any previous state of residence completed once if:

 - d. An address check of the Sex Offender Registry;

Findings:

General: Based on Review of Documentation, the center did not maintain an individual personnel file for each employee.

315 - Educational Requirements

General: Based on Review of Documentation, three employees with the same hire date of 12/01/2011 did not have current documentation from a health professional to verify that they were free from active Tuberculosis.
